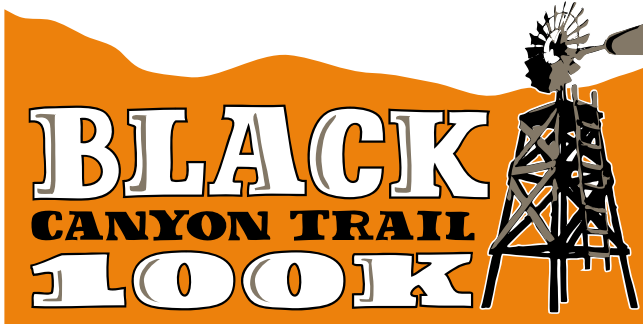

### Course

Point to point course on the Black Canyon Trail (a National Recreation Trail) along single track and non-motorized jeep roads from Mayer High School to the Emery Henderson Trailhead near New River. Maps and elevation profile at [AZTRAILRUN.COM](http://AZTRAILRUN.COM)

### Aid Stations

Nine aid stations spaced 4.3 to 8.6 miles along the course, including water, electrolyte drink, sweet and salty snacks. Five crew access points and four drop bags allowed.

# 2014 Black Canyon Trail 100 Km Entry Form

## Pacers

Pacers may start at the Black Canyon City aid station at mile 36.5 and may accompany their runner to the finish line. Pacers must be one at a time, human and on foot.

## Crews

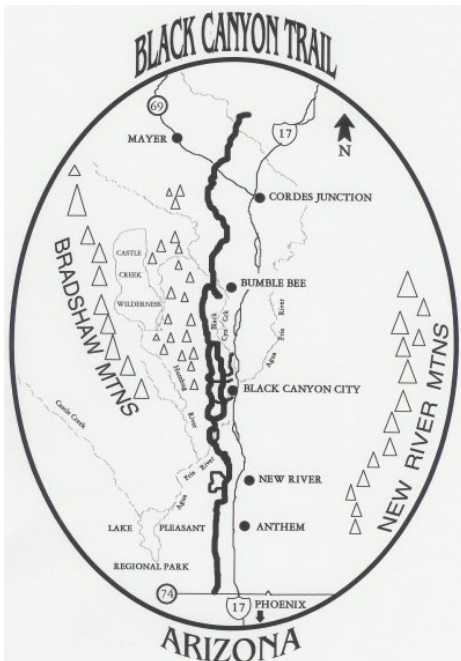
Crews are permitted at the Antelope Mesa (Mile 7.4), Hidden Treasure Mine (Mile 12.3), Bumble Bee (Mile 18.7), Black Canyon City (Mile 36.5), and Table Mesa (Mile 49.6) aid stations.

## Directions to Start (Mayer High School)

If in Phoenix, head north on Interstate 17 (or south on I-17 if coming from Flagstaff) and take exit #262 for Highway 69N at Cordes Junction. Head West on Hwy 69N for 3.0 miles and turn left at Spring Lane. Take the 2nd Left onto Mule Deer Drive and park at Mayer High School.

## Directions to Finish (Emery Henderson Trailhead)

If in Phoenix, head north on Interstate 17 (or south on I-17 if coming from the start line at Mayer High School or Flagstaff) and take exit #232 toward New River. Head West on New River Road for 3.0 miles and look for the Emery Henderson Trailhead on the right side.
