I fully assume all risks of injury, illness or death, and release covenant not to sue, and discharge Estrella Mountain Regional Park, Aravaipa Running LLC, Jamil & Nicholas Coury, USA Track & Field, the race director, volunteers, all sponsors, and any individuals or groups associated with this event, all actions, claims or demands for damages arising out of my participation in this event. The forgoing release is binding upon me personally, as well upon my heirs, executors, and administrators, and all members of my family, or anyone else who may make claim on my behalf. I understand that this event is sanctioned by USA Track & Field and all USATF rules and regulations must be followed. I further grant my irrevocable permission to Aravaipa Running LLC, and its authorized agents, to use my name and any photographs, videos, motion pictures, recordings, or any other record of my participation in this event. A 50% credit of entry fees paid will be available until December 27 good towards any Aravaipa Running event within 1 year of issuance. Entry fees are non-refundable.
