Courses

All runs take place on single track trails and dirt roads within Estrella Mountain Regional Park. Expect typical desert trail conditions including rocks, sand, cactus and gravel. Course maps available at AZTRAILRUN.COM

Aid Stations

Aid stations every 3.3 to 6.6 miles along the course, including water, electrolyte drink, sweet snacks and salty snacks. *Please plan to run with at least one bottle of water!*

Race Goodies & Awards

All runners will receive a technical fiber race shirt (gender specific), finisher glass, and are invited to socialize after the run over hot food, bagels, and fresh fruit. Awards to the top male & female finishers at each distance.

About Estrella Mountain Regional Park

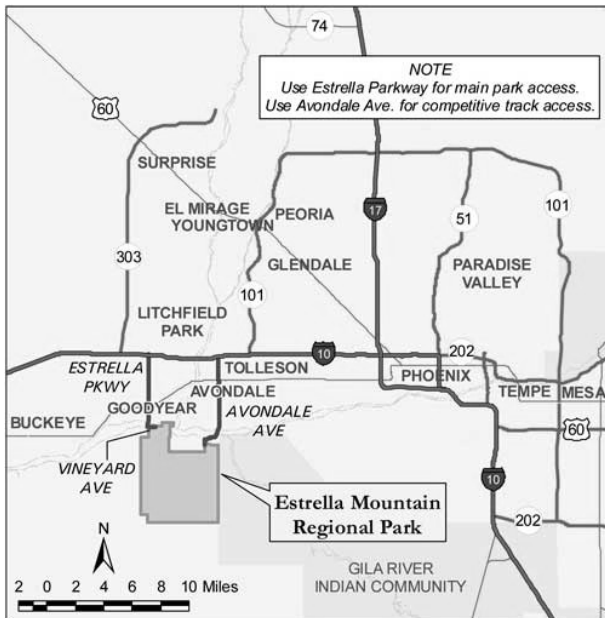
These 19,840 acres of desert and mountains became the first regional park in the Maricopa County Park System in 1954. Located near the meeting of the Gila and Agua Fria Rivers in the southwest Valley, the park includes a large wetland, or riparian, area. The majority of the park remains pristine desert, very similar in appearance to the landscape seen by the first settlers and explorers. The Sierra Estrella range, or Star Mountains, was once within the Mexican border, and remained so until the Gadsden Purchase in 1853. Today, many amenities are available to visitors, including the only grass picnic area in the Maricopa County Park System.

Directions

From central Phoenix, take I-10 west to Estrella Parkway exit. Travel south to Vineyard Ave. Turn east on Vineyard Ave. to the Estrella Mountain Regional Park entrance on the south side. Follow signs to the rodeo arena once in the park.
