I wish to enter and participate in the Across the Years Ultrarunning event. I accept the rules, conditions and regulations of this event and will comply with them. I have sufficiently trained to participate in this event and am in good health. I am capable of making rational decisions and judgments for the safety and welfare of myself. The essence of this release is that the Across the Years ultrarunning event represents extreme and unknown risks for which I freely and voluntarily agree to be solely responsible.

In accepting this entry, I, my heirs, executors, and administrators, hereby waive, release, and discharge the Across the Years ultrarun, Aravaipa Running LLC, USA Track & Field, the City of Glendale, the City of Phoenix, Camelback Ranch, its staff, any official sponsor entity, officers, directors, members, volunteers, agents and employees of each, all medical and other personnel assisting with the ultrarunning event, their representatives, successors, and assigns, from any and all rights, claims, or liability for damage for any and all injuries to me or my property or damage caused by me or anyone else (including Acts of God), arising out of or in connection with my participation in this event, including death.
